ITM University takes appropriate measures to honour and commemorate the social, economic, cultural and political achievements of women in various fields and to raise awareness of discrimination and bias so as to inspire and empower everyone to take corrective action for equality and spread awareness among the people regarding women rights and gender equality through various awareness programs like Self defence programme for women, Beti Bachao Beti Padhao and many more.

Women of National importance, bravery, patriotism, great achievements are celebrated by dedicating their names to buildings, , within the campus. A few examples are Aruna Asif Ali Seminar Hall.The university also ensures an equal opportunity and participation in various fields may it be curricular, co-curricular, cultural or sports activities.

At ITM University safety and security of women are the utmost priority for the management and administration. For women's safety, the university's main objective is to formulate Strategies and policies and implement practices to reduce violence against women. University has created many facilities for women's safety within the premises. All individuals, regardless of gender, caste, language , religion or other status ae given equal rights, resources, opportunities and protections. University unique work culture, healthy traditions and ideology have led for the density of university widen women employees and female students. The university has special cells like women empowerment cell, grievance redressal cell, antiragging committee, cell for prevention of sexual harassment these cell deal with gender issues and women empowerment.



A.Surveillance System

To monitor the behavior, activites of the suspects day and night, CCTV cameras have installed in the whole university campus along with hostels. A control room monitors and maintains records of all day to day activites. If there is any unusual incident, an Action Team calls which is ready for the necessary action. In University, total numbers of cameras are 150.

Safety and Security Facilities

1.24 x 7 security services & patrolling is on duty in and around the campus

To provide a state of feeling safe and free from worry and protection against life's difficulties of life more than 100 security personnel are deployed inside the campus. Security personnel also discharge their duties and responsibilities with pride and Honour all the gates and hostels are being manned by security guards all the girl's hostels have been covered by the female security staff round the clock. Well trained in-house security staffs are posted in different locations to provide safety to all staff and students within the campus.

2. Regular checking of vehicles and people at all entry and exit points.

3. Periodic checking of parking areas, open grounds, college, hospital, hostel, canteen etc.

4. Separate hostels for girls and boys with experienced in-house wardens (male and female) are available 24x7.

5. Faculty and Staff members are assigned to supervise the hostels.

6. Female Junior Assistants are placed in the lecture halls / classrooms / demo rooms to monitor the student activities.

7.ID cards are provided to monitor the student activities.

An extensive electronic surveillance takes place using CCTV cameras throughout the campus and well-equipped control rooms to prevent acts of harassment / violence against women.

The monitor the behaviour or activity of suspects day and night CCTV cameras have been installed in the whole University Campus along with hostels control room monitors and maintains records of all day to day activities if there is any unusual incident an action team calls the authority for the necessary action.

Biometric access has been implemented for entry and exit into college, hospital, classrooms, transport and library.

Prominent Helpline posters with visuals are displayed throughout the campus for emergency.

Free ambulance service is provided to all inmates within the campus.




The university has constituted an active Complaint Cell for prevention of sexual harassment of women working in the university.


Orientation program is conducted for all newly admitted students sensitizing gender issues.







Adequate lighting facilities throughout the campus is provided to ensure the safety









Every academic and administrative infrastructure of the university has separate wash rooms for girls students and female employees to ensure their safety.





Students and staff of the university are provided with the bank and ATM facilities within the campus.







RESPONSIBILITIES OF ANTI-RAGGING COMMITTEE



On receipt of the recommendation of the Anti Ragging Squad or on receipt of anyinformation concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so,either on his own or through a member of the Anti Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within 24 hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of thefollowing, namely:

- Abetment to ragging
- Criminal conspiracy to rag
- Unlawful assembly and rioting while ragging
- Public nuisance created during ragging
- Violation of decency and morals through ragging
- Injury to body, causing hurt or grievous hurt
- Wrongful restraint
- Wrongful confinement
- Use of criminal force
- Assault as well as sexual offences or unnatural offences
- Extortion
- Criminal trespass
- Offences against property
- Criminal intimidation
- Attempts to commit any or all of the above mentioned offences against thevictim(s)
- Threat to commit any or all of the above mentioned offences against thevictim(s)
